I. General Business:

- a. Adopted minutes from 3/21/2016 meeting No further action required.
- b. Membership Member Ken Barber's request to resign as a full Member and become an Advisory Member of the EC, has been forwarded to Mayor Doug Frank and Liaison Pizzella. Resident Bob Cinek, interested in joining the Environmental Commission, will be recommended to the Borough Council for upcoming appointment.
- **c. Budget** 2016 Budget has been approved as unchanged from 2015, no further action required.
- d. Training No action.

II. <u>Correspondence:</u>

- **a. New Correspondence** We have received enthusiastic RSVP for the Town Clean Up, and expect a good turnout for the event.
- **b. EC Email inbox** No new Plans.
- III. <u>Tree Maintenance Meeting:</u> Ken Barber, John DeJoseph, Dan O'Rourke, Scott Raymond & Elizabeth Snieckus met 4-11-16, to discuss ongoing Tree Maintenance issues.
 - **a.** Tree City USA Application—Ken Barber & Scott Raymond will continue to work on Tree City USA Application.
 - b. R.O.W. Street Tree Removal Policy John DeJoseph confirmed that the current Borough policy to carry out tree removals within the street easement, will continue as is. Residents will request DPW tree pruning &/or removal through the "Report a Problem" format on the Town's Website. The DPW will do a quick evaluation and request a referral from Tree Expert Ken Barber, if warranted. An outside contractor will continue to provide tree removal services via contract with the Borough. DeJoseph recommended that the DPW reserve \$5,000 of the tree removal budget for emergency storm events.

- c. Tree Bank DeJoseph informed the group that the current Tree Bank balance, from Developer's Zoning approval obligation is \$23,000, and is for tree planting and tree replacement ONLY. The current contribution amount of \$275 per 2-2.5" caliper tree, as designated by the Borough Tree Ordinance, for replacement of removed trees, is several years old and should be updated to reflect the rate of inflation for current pricing. DeJoseph will look into revising the Municipal Fees within the Town Ordinance.
- **d. Street Tree Planting Policy -** EC Advisor, Ken Barber, &/or EC members will recommend tree planting species and location, if requested by a resident. Fall Planting season was recommended to be designated as September through October. DeJoseph recommends keeping tree budget under \$17,000, and holding \$5,000 in reserve for emergencies.
- e. Tree Ordinance DeJoseph asked that the EC review the current Tree Ordinance for Land Development, and offer suggestions for changes in language and content. Suggested that we amend current Hillsdale Ordinance to define "Tree Maintenance" as "generally to include but not be limited to pruning, feeding, cable support, pesticide application, but EXCLUDING tree removal". He and Dan O'Rourke will work on the tree R.O.W. policy, and submit suggested changes to legal team for review.
- IV. <u>SUEZ-United Water Reservoir, Planting & Walkway:</u> Ed Alter attended SUEZ meeting with officials from Woodcliff Lake, Park Ridge and Hillsdale to discuss nature trail plans.
 - a. New path will be for walking and fishing only. No pets or bicycles will be permitted.
 - **b.** SUEZ will be pursuing DEP permits and watershed grants for the project.
 - c. Hillsdale's Church Road plantings were recommended by Lori Sharkey of Bergen SWAN.
 - **d.** The new Reservoir concrete spillway has an unanticipated consequence of significant sound reflection and amplification of vehicles passing over the reservoir road. Adjacent residents are severely affected and a remedy must be sought. Borough Engineer Chris Statile is to address the issue.
 - **e.** Concrete was to be painted green to minimize visual impact, and has not yet been done.
